1. Chief-Executive's Report

Introduction and Context

I submit for your consideration the Three-Year Capital Programme for the period 2025 – 2027. The capital programme is prepared having regard to the amount of capital funding that is already confirmed from external or internal sources and, as is the case in the majority of the 2026 and 2027 projections, is based on best estimates available at this time.

In that context, the Three-Year Capital Programme estimates that Donegal County Council's total capital expenditure for 2025 will be of the order of €417,864,691, with capital expenditure for the three-year period estimated to approach €1,855,451,771.

In recent years, the opportunity to engage in larger scale capital investment in the County has increased significantly, aided in no small part by the additional funding opportunities that have been sought and secured from sources at national government level, and on a cross-border and trans-European basis.

Total capital expenditure in 2023 amounted to \le 161,613,970, with the 2024 capital budget amounting to \le 248,788,949. The following table provides a clear indication as to the rate at which Donegal County Council's capital expenditure has been increasing in recent years.

As always, the Council will continue to focus on efforts to maximise funding opportunities for capital investment in the County. Donegal County Council is well positioned to develop, compete for, and deliver capital investment projects, of all scales, large and small, that can respond to the challenges we face and accelerate economic development in the County and in the northwest region. As has been stated previously, the scale of the Council's ambition remains high, and we continue to

allocate resources to bringing forward projects and programmes of work that can deliver on our developmental goals for the County.

Like many opportunities arising for capital and infrastructure development, such projects will require a significant contribution from Donegal County Council in terms of co-financing and project development/management. Whereas this is a challenge that must be managed, it is essential that every effort be made to seize the opportunities that now present for large-scale infrastructural developments, which are impactful over the longer term, and have the potential to enhance the economic, social and community fabric of the County for the benefit of the County's citizens and businesses.

The draft Revenue Budget 2025 contains a $\in 100,000$ provision to kickstart an examination of the Council's accommodation needs at its Lifford headquarters. This development will ultimately require an investment of several million euros and will be included in future capital budgets.

Some of the primary areas of expenditure in 2025 will involve:

- A focus on progressing the housing capital programme, with 200 units to continue in construction on Council land into 2025, with a further 249 units due to commence in 2025, and with an estimated cost of €85.3m.
- In addition, four turnkey projects comprising 88 units will continue on site into 2025, with a further three turnkey projects, comprising 77 units, expected to commence on site in late 2024 or early 2025, with an estimated total spend during 2025 of €29.6m.
- 18 house acquisitions are also included in the Capital Budget for 2025 at a cost of €3.74m.
- Further interventions in the Social Housing area through the Energy Efficiency Retrofit Programme, Capital Assistance Schemes through Approved Housing Bodies, Voids Programme and Extensions & Adaptation Works.
- Continuing to implement the Countywide Footpath Programme, under which a total fund of €6.7m has been set aside, with specific works being agreed at Municipal District level.
- Publication and progression of the Ten-T Priority Route Improvement Project Donegal through the Statutory Planning process in 2025/2026 by the National Roads Office. This project is joint funded by TII and the Connecting Europe Facility funding.
- Continued investment in improvement projects along the N56 roadway and other national roads.
- Project management of TII funded programme of new Greenway infrastructure across the county through the National Roads Office.
- Continuing investment through the Marine Capital programme for piers and harbours.
- Continued investment in the Regeneration and Development of strategic Towns across the County through the URDF and RRDF programmes.
- A continuing programme of investment in strategic economic infrastructure supporting the community and tourism sections and including iconic attractions.
- Continued investment through EU sourced funds and across multi-sectoral areas.

- The continuation of a multi-annual programme to maintain the Council's capacity in the areas of Information and Communications Technology.
- The further progression of Taking-in-Charge of estates and in the completion of works to remediate unfinished housing estates.
- Investment in environmental areas including landfill remediation, recycling, beach improvement, and leisure centres.
- Investing in climate action and climate mitigation measures across all sections of the Council where opportunities arise.
- Investing in energy-saving initiatives in Council buildings and advancing the development of the North West Energy Agency.
- Working with Zero Emission Vehicles Ireland and others in the development of a network of electric vehicle charging infrastructure.

Co-funding from Own Resources

The principal sources of generating the local contributions required to co-fund external capital investment are:

- 1. Loan Financing
- 2. The Development Contribution Scheme (DCS)
- 3. Transfers from Revenue
- 4. Use of Reserves

The level of income available from the DCS Fund can only be applied to the extent that it has been collected (i.e., cash received, not as accrued/levied). Similarly, the availability of transfers from Revenue, as a source of co-funding for capital investment, remains limited – as Members will be aware from the annual Revenue Budget discussions and meetings. Additionally, the judicious use of limited Capital Reserves, established in many cases from operating surpluses on the Revenue Account, provides additional capacity in limited but targeted areas. The Council's ability to service new borrowings in respect of capital works is, as always, determined by the extent of the Council's capacity to fund repayments from the Revenue Account, and must take account of existing commitments.

In the last few years, loan financing in the sum of \in 33m has been drawn down (\in 7m of which has a corresponding income line from Donegal 2040 DAC). These loans are repayable at fixed rates over a 20-year period. However, additional borrowing capacity and/or concessions with respect to the level of grant funding or rate of cofinancing will be required to fully deliver the capital programme in the years ahead. Recent calls for RRDF projects have offered Donegal a reduced co-funding requirement of 10%, which is helpful and acknowledged.

Notwithstanding the considerable co-funding constraints outlined, the Council will continue to seek to ensure that it is best placed at any given time to be able to take advantage of potential capital funding opportunities that arise.

Proposals for the 3-Year Capital Programme 2025 – 2027

A Three-Year Capital Programme in the sum of €1,855,451,771 is presented for the period 2025 – 2027, broken down per Programme Group as detailed in the Statutory Tables.

The Statutory Tables reflect the gross estimated expenditure for the period 2025 – 2027 (noting my earlier comments relating to the unknown detail of capital funding generally in respect of 2026 and 2027).

As previously stated, it is only the first year of the three-year programme that can be presented in detail. Each Director of Service has provided an analysis of proposed expenditure for their respective directorate, which is included in the detail of this report. The table that follows this introduction provides an overview summary of capital expenditure per directorate for 2025.

The total estimated capital expenditure of $\[\le 417,864,691 \]$ as indicated for 2025 is conditional on a range of factors and assumptions, including the allocation of grants, level of DCS collectable, loan sanction approval from DHPLG, and availability of cofinancing.

The work of the Council in the years ahead, in terms of capital investment in a post-Brexit and post-Covid environment, will be extremely important to the County and its citizens. The Council will remain ambitious in terms of developing and competing for capital investment opportunities and maximising sources of external funding for worthwhile and impactful projects. The Three-Year Capital Programme 2025 – 2027 reflects that level of ambition, and I would like to thank the Elected Members for their vision and for their role in guiding and supporting the projects and proposals that are contained within this programme.

2. Director of Finance's Report

In preparing the Three-year Capital Programme, the Council is required, as per Section 135(3) of the Local Government Act 2001 (as amended), to ensure that:

"In considering the question of resources likely to be available to it, the local authority shall so consider [the Three-Year Capital Programme] -

- (a) on the basis of a realistic and prudent assessment of the [financial] position [of the local authority], and
- (b) on the basis of the information available to it at the time and having regard to the measures proposed by the authority to raise funding itself."

The Council continues to apply a rigorous approach to the management of capital projects and programmes, with a continued focus on managing projects within approved and defined budget lines. The objective of this is to ensure that no unfunded capital balances arise.

Available budgets from external sources (department allocations, other grants, etc.) and from internal sources (reserves, Development Charges, etc.) are detailed within this report. Development Charges, in line with audit requirements, are reflected on a cash-collected basis i.e., the Development Charge figures quoted in this report reflect the best available estimates of the actual cash that is expected to be collected from this source during the three-year period 2025 to 2027.

Similarly, it should be noted that proposals may also rely on the current best estimates as to the funding elements and sources anticipated to be available during the period 2025 – 2027, especially in instances where confirmation is still awaited on a definitive funding package for a particular project or programme. It should be noted that projects will only proceed on confirmation of a complete funding package.

There is always a level of uncertainty as to the degree of availability of capital funding in the medium to long term. This means that only projects and programmes for 2025 can be presented in detail. Therefore, in general, the level of capital activity and funding available for the years 2026 and 2027 is presented on the basis of best estimates as to the level of funding that is anticipated to be available for those years.

3.1.1 - Housing Construction Programme 2025 - 2027

The Council plans to deliver over 1,200 units under Housing for All over the period 2022-2026. The table hereunder sets out the projects planned for delivery over the period 2025 – 2027.

The below tables set out social housing projects at various stages of progression across all delivery streams, all of which will contribute towards social housing delivery over the coming three-year period.

3.1.2 - Social Housing through Turnkey Acquisition

The turnkey acquisition model is progressing in towns throughout the County and delivery of high-quality housing in significant numbers will be provided. This is one of the key mechanisms being used to meet the social housing need under the current Social Housing Investment Programme. 4 project sites comprising of 88 units will continue on-site into 2025, with a further 3 turnkey projects, comprising 77 units, expected to commence on-site in late 2024 or early 2025. Below are projected costs associated with turnkey acquisitions over the period 2025 – 2027:

3.1.3 - House Acquisition Programme (Single Units)

3.1.5 - Land Acquisition

The Council is currently utilising the Land Acquisition Fund, managed by the Housing Agency, to acquire lands for social housing purposes. This process involves the Council identifying suitable lands, carrying out due diligence exercises, agreeing the acquisition, and the Housing Agency undertaking the conveyance stage – with the effect that capital expenditure is directly incurred by the Housing Agency, rather than the Council.

3.1.6 - Approved Housing Body Sector

The projections in respect of delivery to be provided by the AHB sector through the Capital Assistance Scheme and Capital Advanced Leasing Facility are set out below.

3.1.7 - Improving the Social Housing Stock

The Department of Housing, Local Government & Heritage provides funding under a number of programmes for Local Authorities to refurbish and improve the social housing stock. The detail of these programmes is set out below:

a) Energy Efficiency Retrofit Programme

This programme was introduced in 2021 to retrofit social housing units to a B2/Cost Optimal standard. Since its introduction, the Council has secured funding of €15.5m under the Programme, which will see a total of 664 units in sixteen estates throughout the county retrofitted by the end of this year. The works carried out has covered insulation works, windows and doors replacement, heat pumps and BER Certificates, both pre and post works. The Council will continue to engage early with the Department each year going forward to ensure that we can maximise funding to provide more energy-efficient homes for our tenants.

b) Returning Void/Vacant Properties to Productive Use

The Council has been successful again this year in making bids to the Department for funding under the Voids Programme, which was introduced in 2014. By the end of 2024, the Council will have refurbished over 1,308 vacant properties to a high standard of re-letting under the Programme. Over €10.7m will have been sourced from the Department under the programme by year end, with the balance funded from the Council's own resources. The Council will continue to source funding from the Department under this Programme. The expenditure and income associated with the operation of this programme is accounted for in the Revenue Account.

c) Extensions and Adaptation Works

The Council carries out small-scale adaptation works, including extensions, to its social housing stock on an ongoing basis as needs arise. In most cases, this is for tenants with special needs and/or disabilities, with approximately 90 households benefiting from works carried out under this programme on an annual basis. An annual spend of €900,000 is anticipated in this regard. The Council can recoup 90% of the expenditure from the Department, with the balance being funded from the Council's own resources.

3.1.8 – Assistance to Persons Improving Houses

Financial assistance is available to private homeowners to improve their homes under the Housing Adaptation Grant, Mobility Aids Grant, and Housing Aid for Older People Grant schemes. The Department has provided 80% funding towards these grant schemes with the balance funded from the Council's own resources. The Department has indicated that they will fund 85% going forward as part of an updated scheme with increased grant amounts and updated eligibility criteria.

3.1.9 - Traveller Accommodation

On 30th September 2024, the Traveller Accommodation Programme 2025 – 2029 was adopted by the members of Donegal County Council.

Through the lifespan of the previous programme, the Council delivered and met all targets and objectives as set out in the programme on a yearly basis in consultation with the Local Traveller Accommodation Consultative Committee. Significant improvement programmes were implemented on all Traveller-specific sites in the County, both from an accommodation and fire-safety perspective.

A number of additional small scale Traveller accommodation projects were completed throughout 2024 and a range of other accommodation solutions were delivered through standard lettings, HAP, and LTL schemes. In addition, mobile home and caravan replacements were provided in specific emergency accommodation cases as well as other accommodation interventions including modular home, extensions etc.

It is anticipated that targets and objectives as set out in the final year of the current Traveller Accommodation Programme will be achieved. A significant suite of Traveller-specific capital projects are at varying stages of preparation for delivery in the first year of the new Traveller Accommodation Programme including dwelling rebuild (\in 347,000), group housing refurbishment (\in 60,000), modular home provision (\in 90,000), refurbished permanent halt (\in 30,000), and a number of acquisitions are also proposed over the first two years of the plan (\in 360,000).

3.1.10 - Defective Concrete Blocks - Social Housing.

The Defective Concrete Blocks Grant Scheme for private homeowners is administered by the Council on behalf of the Department of Housing, Local Government & Heritage. Grants payable under the scheme are fully recoupable from the Department. Our social housing stock is also affected by Defective Concrete Blocks. Further to the most recent meetings with the Department, it is anticipated that the Council will receive

approval shortly to commence the process of remediating affected vacant social homes in early 2025 and also carry out preventative works on properties to keep tenants in their homes for a number of years until alternative accommodation can be found and their properties remediated permanently.

<u>Section 3.2 – Cultural Services Division</u>

3.2.1 - Projects Planned

Libraries Capital Investment Programme

The Council was successful is securing €1m part-funding through the previous Libraries Capital Investment Programme from the Department of Rural and Community Development towards the overall cost of developing a new library in Donegal Town. An application for Stage 1 approval, for a further €2.1m, under the new Libraries Capital Investment Programme 2024-2027 was submitted to the Department of Rural and Community Development but was unsuccessful on this occasion. The Council is exploring options for additional funding. It is the Council's intention to meet with the Department with a view to discussing further and potential next steps. Anticipated expenditure is outlined below.

Archives Centre

The plans to develop an Archives Centre at the Prior School in Lifford, to properly preserve and make archives publicly available. Following the initial preparation of a conservation report in 2021, funding was sourced from the Historic Structures Fund to cover asbestos and bat surveys and allowed for remedial works to render the building waterproof.

Given the nature of the building, tenders were sought from suitable Architectural Practices with a view to preparing a Feasibility Study with Architectural Conservation Design and Cost Estimate Services for the project. Dedalus Architects were recently appointed to carry out this work, following which additional external funding sources will be explored to develop the Prior School as the Archives Centre.

The reuse of the historic Prior Endowed School will assist in the conservation of this proposed protected structure in the ownership of Donegal County Council and is consistent with Donegal County Council's responsibilities in addressing climate change.

Other Cultural buildings

It is expected that further investment in improvement works in other cultural buildings will be made by the Council during the lifetime of this capital programme. Some of these works relate to ventilation, insulation, and energy saving, as well as to general repairs and maintenance, working towards having planned preventive maintenance rather than reactive as at present. In addition, there will be investment to ensure compliance with statutory requirements and to improve health & safety standards and accessibility.

Historic graveyards

At least 50 historic graveyards are in the care of Donegal County Council. These graveyards are social and cultural assets and of interest to the Donegal community at home and abroad. The Council, taking a cross-directorate approach, proposes to explore internal and external funding sources during the next three years to enable conservation plans and appropriate works to be carried out. These historic graveyards are archaeological monuments in the guardianship of Donegal County Council and protected under the National Monuments Acts. The proposed research and conservation works will assist Donegal County Council in meeting its statutory obligations.

Capital funding projections for the three-year period 2025 to 2027 in respect of the above projects are as follows:

4. Roads & Transportation

4.1 - National Roads Major Capital Projects

All National Road projects are fully funded by Transport Infrastructure Ireland, except for the Ten-T Priority Improvement Project and TEN-T N13 Bridgend to County Boundary Route Improvement which are currently part-funded by the EU CEF (Connecting Europe Facility). The government funding profile for the TII over the next four years is set out in the National Development Plan 2021 to 2030. The spend nationally on National Roads is significantly diminished and this downward trend is expected to continue up to 2026. This current national investment policy does not positively discriminate in favour of regions such as Donegal and the North West which did not benefit from the roll out of the Motorway Network over the last 25 years.

All National Road projects are planned and designed with full cognisance of evolving national policies, including, but not restricted to, national climate action and sustainable development policies. A significant Active Travel and Greenways programme is currently underway across the county. All Greenway projects and Active Travel projects on national roads such as on the N56 in Letterkenny are funded by TII. The N56 projects are particularly important as they incorporate traffic management improvements at key junctions.

4.1.1 - TEN-T Priority Route Improvement Project, Donegal

The TEN-T Priority Route Improvement Project (TEN-T PRIP) involves three priority sections of the National Road Network in Donegal.

- Section 1 N15/N13 Ballybofey Stranorlar Urban
- Section 2 N56/N13/N14 Letterkenny to Manorcunningham, including N13 Lurgybrack, dual carriageway upgrade to Manorcunningham Roundabout, and N56 link road over R. Swilly to Creamery Roundabout on N56/Ramelton Road.
- Section 3 N14 Manorcunningham to Lifford/Strabane

In 2024, following the submission of the Preliminary Business Case to the Department of Transport (July 2023), government approval was received to enable the scheme to progress to the Statutory Planning process. This is a significant milestone for the project. Publication of the EIAR and CPO are expected in Q2 2025. It is anticipated that an Oral hearing will be required, and this may commence as soon as the end of 2025.

The NRO project management team continues to liaise with property and landowners that are likely to be impacted by the scheme.

The projected expenditure profile allows for the completion of statutory processes and oral hearing between 2025 and 2026. The start of the process and the overall schedule of expenditure is wholly subject to the timing of Government, Department, and TII approvals. The completion of the process is subject to Statutory Process, Oral Hearing, and potential Judicial Review. Initiation of procurement process, essential advance works such as Archaeology, and some land acquisition may still be possible as early as 2026. The method of delivery of the project as a whole or section-by-section has not been determined as yet. However, it is important that all sections of the project proceed through the Statutory Processes together. CEF funding will conclude in 2025. It is critical that continued funding is secured to enable the project to continue to progress forward.

4.1.2 - N14/N15 to A5 Link and A5 Western Transport Corridor

The N14/N15 to A5 Link structure and associated elements are now progressed and integrated fully into the TEN-T PRIP CPO, EIAR and Design Report. Donegal NRO continues to liaise and consult fully with the Department for Infrastructure (DFI) Northern Ireland regarding design, programme, and planning, as well as transboundary impacts and assessments.

The Planning Appeals Commission (PAC) inquiry on the A5 WTC concluded on 2nd June 2023. On the 2nd October 2024 the Infrastructure Minister in NI announced the intention to proceed to construction on 54km of the project starting just south of Strabane and going as far as Ballygawley. A further 31km of the project, which includes the section from Strabane north to New Buildings and from Ballygawley to the border at Aughnacloy await further approval by the Minister.

4.1.3 - Current National Roads Major Capital Projects at Construction

Major recent works on the N56 in the west of the County are now substantially complete, with N56 Dungloe to Cloughbolie and the N56 Letterilly to Glenties (Kilraine) Phase 1 closed out. The final section from Glenties to Kilraine is on site and will be completed in 2025. A formal opening ceremony to mark the completion of the sections to date was held in April 2024. This €100m investment through TII has been successfully delivered through the Donegal NRO and very welcomed by all.

4.1.4 - Current National Roads Major Capital Projects at Design Stage

TEN-T N13 Bridgend to County Boundary – Northern Ireland Border (Derry)

The N13 Bridgend to County Boundary (TEN-T) Route Improvement Project focuses on a 1.2 km long section of the N13 National Primary Route through the village of Bridgend and onto the border with Northern Ireland (Derry), where it connects to the A2 Buncrana Road.

Phase 2 – Options Selection for this project is now complete with a preferred route corridor has been identified. Following TII approval the project will now progress to Phase 3 – Design and Environmental Evaluation in 2025. This project has secured cofinancing from the European Commission's Climate Infrastructure and Environment

Executive Agency (CINEA), under the current Connecting Europe Facility Programme (CEF II). It is expected that with CEF funding the design and planning phases will be completed by 2025, however, the future progression of the project beyond that will depend on the securing national investment in new roads infrastructure.

Other minor projects at Design Stage

Other minor projects (below €20m) which will continue to Progress through planning and Design in the next financial period 2025 to 2027 include:

- N56 Doonwell to Drumbrick
- N15 Corcam Bends
- N56 Falcarragh-Gortahork

4.1.5 - Current National Roads Major Capital Pipeline Projects

As previously advised the following 'pipeline' projects are a sample of those currently being promoted by DCC for TII funding:

Funding for further Major and Minor projects is continually sought from TII to deal with the remaining legacy and below standard elements of our national road network particularly the TEN-T sections.

4.2 National Road Safety Projects

Safety projects on national roads are funded through TII for schemes identified from HD15 Network Safety Ranking and NRA HD17 Road Safety Inspection.

4.2.2 - Safety Schemes at Design

N14 Feddyglass RSIS and Pavement Project

The N14 Feddyglass project is substantially completed.

N15 McGroary's Brae

This project is now substantially completed.

N15 Lough Mourne

This project is being completed in 2025 under approved and funded change order the N15 McGrory's Brae Contract.

N15 Laghey

This project will provide a new roundabout junction at the busy R232 Pettigo Road/N15 intersection. Part 8 planning has been completed successfully and subject to land acquisition and funding the project will go to tender in 2025.

N3 Lissacholly

Design of this junction continues to be progressed.

4.3 - Greenways and National Road Active Travel

4.3.1 Greenways

There are currently a number of TII funded Greenway projects being delivered across Donegal. Details of these projects and their allocations are provided in the table below. These are being managed by the Donegal National Roads Office in conjunction with a dedicated team from the DCC's Road Design Section.

Progress will be dependent on approval of funding by TII under 2025 allocation.

4.3.2 National Roads Active Travel

A pipeline of active travel projects along our National Road network will continue to be developed around the county. An allocation was received in 2024 for the **N56 Letterkenny Urban (Dry Arch Rdbt to Mountaintop Rdbt).** This phased project will look at both traffic management and active travel along and across the urban N56 in Letterkenny. The project will be delivered in conjunction with implementation of applicable elements of the Letterkenny Transport Plan. The current phase following on from the N56 Four Lane Road upgrade and Polestar roundabout signalisation project is currently at Tender with construction to commence in 2025. This section will provide essential active travel facilities on the N56 between the Polestar and the Creamery roundabout. It will also provide junction improvement (signalisation) of the Ballyraine and Creamery Roundabouts.

Subsequent phases will include the N56 Creamery Roundabout to the Knocknamona roundabout and from the Knocknamona roundabout to the Mountain Top. Further assessments, planning and design are required on these elements through 2025 to 2027.

Other Active Travel Projects being pursued are:

- N15 Cappry (Cappry to Ballybofey Speed Limits)
- N56 Ardara to Glenties
- N56 Portnablagh
- N56 Dunkineely/Bruckless

4.4 - National Road Pavement Strengthening Design and Construction

Donegal NRO continues to work in partnership with TII to prioritise proposed PARR projects on a rolling 3-year programme. There are strong indications are that overall funding of the PARR program will reduce over the coming years. A program of projects will continue to be designed and delivered by the NRO subject to funding.

4.5 - National Roads - Estimated Capital Spending for 2025 to 2027

The predicted capital spend for 2025 to 2027 for the NRO is €62.3m. All is TII funded with the exception of CEF funding on the TEN-T projects in 2025. Major expenditure into 2026 and 2027 are dependent on progress on greenways and the statutory process on the TEN-T PRIP.

4.6 - Non-National Roads Projects

Generally, Road Safety and Bridge Maintenance / Rehabilitation works projects are funded annually through the Department of Transport in accordance with circulars as issued.

Progress continues on the two large strategic projects – these projects must follow phased processes and associated approvals by the DOT – these projects can take a significant number of years to deliver:

R263 Fintra Bridge and Realignment Project

- ➤ CPO approved by ABP in 2022, with Notice to Treat issued in 2023 and land purchase process ongoing.
- ➤ Tender for procurement of main contractor commenced in Q3 2024
- Construction to commence in Q2 2025

Letterkenny Southern Network Project

- > Strategic Assessment Report was approved in 2022.
- Consultant appointed to progress Phases 1 and 2 in accordance with the Project Management Guidelines Project
- Route Selection Public Consultation to be held in Q4 2024 and Phase 2 will be completed in 2025.

The Department of Transport Roads Memorandum determines the type and nature of projects that are applicable for Specific Improvement Grant Funding. The Council is progressing with those DOT approved projects with one additional project per MD to be submitted on completion of previous projects. The current projects are as per determined by the previous Plenary Council in 2021 while future projects will be agreed at MD level and a preliminary appraisal will be submitted to the DoT for consideration.

In support of Letterkenny Northern Network Project, the DOT seek Council co-funding allocation – it is proposed to proceed to land purchase in 2025 for Section 3 of the Route to facilitate progression to construction in 2026.

NTA Active Travel

NTA Active Travel funding has been allocated since 2021 and significant work has been carried out at smaller town/village locations over the first 3 years with many of footpath projects constructed by the Area Roads teams. The NTA has allocated €4.5M to DCC each year for the previous number of years and it is likely that funding will be maintained at this level in the coming years. The NTA has advised that for the next phase of funding, larger scale active travel projects incorporating cycle facilities in larger population towns will be prioritised. The design/planning stages for the more complex projects are now well underway and will facilitate the delivery of larger scale cycle infrastructure and modal shift opportunities including the reassignment of existing road space to alternative transport modes.

4.7 - Public Lighting

The Council manages and maintains its full inventory of lighting stock through its public lighting management information system. Public Lighting is a significant energy user, using 50% of the Council's total power usage to light our route network. The Government energy targets require the Council to reduce its energy usage by 50%, from a baseline in 2016, which equates to a reduction of 3M kwh.

To deliver on this energy reduction, the Council embarked on a programme of upgrading public lighting from traditional SOX/SON lamps to energy-efficient LED lamps through various projects funded through revenue budget, TII grants and loan funding, through the support of Elected Members.

Progress on Energy Reduction:

2016 15,000 public lights @ 6 MWh power usage with 0% LED

2024 19,500 public lights @ 4.1 MWh power usage with 82% LED

Despite a 30% increase in the Council's lighting stock, a 32% reduction has been achieved in the total energy usage. The Council will continue with its LED retrofit programme over the next 2 years with the focus turning to the higher wattage SON lights replacement. Funding will be drawdown from DOT and HFA to support the

Council's allocation. This should substantially complete Donegal's public lighting energy efficiency programme and achieve the required energy reduction and associated national 2030 target.

4.8 - Footpath and Lighting Programme

Since its inception some years ago, the Council have spent over €4m Countywide on the repair of footpaths and the infilling of public lighting gaps on the non-national public road network, with many projects earmarked for attention following dialogue with elected members. The Council have committed a further €1.7 to be spent over the coming years, to be collectively funded by a combination of funds from IPBMI, State/Agency Grants, Development Charges, and other own resources.

4.9 - Vehicle Restraint Systems

Whilst TII have programmes in place for the renewal of existing VRS that may have been damaged, or for VRS that require improvement and for locations where a new VRS is required, no such programme currently exists for the Non-National Road network.

On Regional and Local Roads, the Department for Transport fund the erection of some new VRS at locations where they are required through their accident prevention programme. However, no programme exists for the repair or renewal of VRS that have been installed in locations in the past and where there are no current accident statistics at the location.

All new installations of VRS, whether at a new location or at the site of a legacy VRS, must be designed in accordance with current standards and specifications. It may be the case that the location of a legacy VRS may not be suitable for the erection of a new VRS, and additional or alternative works may be required at the location. There are sections of legacy VRS that require re-assessment due to changes in the adjacent road alignment or due to potential deterioration since they were first installed. Representation has been made to the DOT for the initiation of a funded programme for the assessment of locations of legacy sections of VRS and addressing the hazards that are identified at these locations. It is proposed that, at a Municipal District level, Elected Members may utilise Minor Infrastructure and Public Lighting Fund to commence a programme of assessment of locations of legacy sections of VRS and addressing the hazards that are identified at these locations.

4.10 - Piers & Harbours Capital Development

Donegal County Council owns, manages, and maintains 101 harbours along the Donegal coastline. It has invested €47m (sourced from DAFM, DAFM/BALAMI, An Roinn, BIM and Council Capital contribution) in Piers & Harbour infrastructure in the last 11 years.

Over the last 3 years and subject to final completion of works, €30m of significant capital investment will have been provided through the DAFM, co-funded by Donegal County Council, has been spent on the management, design and construction of projects at 24 of our 101 piers.

Applications will be made under any DAFM programme offered for 2025-2027 in accordance with the terms and conditions of same. Maximum annual funding is expected to be in the order of €300k. Works that can be applied for include:

- Pier & Harbour Safety Measures
- Aids to Navigation (AtoNs)
- Crane/Winch facilities
- Pontoon provision (where FSL is approved)

In 2024, the Piers & Harbours team, while still delivering on the large construction projects, also commenced work on the preparation of Foreshore Leases for new pontoon projects (circa €200k per project) over the next 5 years.

The team will continue to develop projects at Greencastle, Burtonport and Port Pier Inver in consultation with local groups and partnership opportunities, subject to necessary Foreshore Lease requirements. Once projects have been identified and Foreshore Lease requirements secured, funding will be sought.

Following ongoing engagement with the Island's Committee, the Piers & Harbour's team continues to liaise with Roinn na Gaeltachta with respect to improvement works at Rannagh Pier and Magheraroarty Pier.

4.11 - Roads Projects Funded from Development Charges

The total estimated amount of General Development Charges that will be provided for the Roads Directorate is currently estimated at €250,000 annually for the period 2024 to 2026. These estimates will be the subject of further review in advance of each respective budget year and will take account of the payment trend of Development Contribution Scheme at that time to update the expected available budget accordingly.

The projects to be built under available Development Charges will be prioritised by the Municipal Districts.

In addition to general DCS, the Council collects Specific Development Charges for specified works required to facilitate specific developments, and these charges will be spent on the projects for which they are levied.

4.12 - Projects Funded from Private Works Contributions

From time to time, monies are made available to the Roads Department to undertake specified works on the public road network. An example of this would include funding for the repair of roads damaged by third parties (e.g., EIR, Uisce Eireann, etc.). Projects of this nature are reported as capital projects. However, they tend to be of low value, short duration, and impossible to predict in advance with any certainty. Such projects are mentioned here for completeness but will not form part of the Roads Capital Budget.

4.13 - Electric Vehicle Charging Infrastructure

Zero Emission Vehicles Ireland (ZEVI) was established in July 2022 as a dedicated office within the Department of Transport (DoT) to support consumers, the public sector, and businesses in continuing to make the switch to zero-emission vehicles. In order to achieve this ZEVI have developed the National EV Charging Network Plan. This plan focuses on two areas with the National Road/Motorway Network EV Charging Plan being led by TII and the Regional and Local EV Charging Network Plan being led by Local Authorities.

The National Road/Motorway Network EV Charging Plan aims to provide a network of high-speed EV chargers for en-route charging. TII are progressing this on a phased approach with the first tranche of high-speed charging infrastructure announced for the motorway network recently. The next phase focuses on the TEN-T Comprehensive Network and a grant scheme is currently advertised which aims to provide fast charging facilities at intervals on no greater than 60km along that network. This covers the N15 from Bundoran to Stranorlar, the N13 from Stranorlar to Bridgend and the N14 from Lifford to Manorcunningham. A further phase will then focus on the remaining National Road network.

The Regional and Local EV Charging Network Plan aims to provide destination and neighbourhood charging facilities. Local Authorities are being funded to develop strategies that will establish the number and location of these facilities. Local Authorities are working on a regional basis to ensure that the infrastructure in neighbouring and similar local authorities provides a consistent, predictable and interoperable network for EV users. Donegal County Council is the lead authority for the west and north of the Wild Atlantic Way and includes the local authorities in Clare, Galway County, Mayo and Sligo.

5. Water & Environment Services

5.1 - Water Services

5.1.1 - Uisce Éireann

The Water Services (No. 2) Act of 2013 transferred responsibility for policy and funding for public water services from local authorities to Uisce Éireann (now Uisce Éireann). The responsibility for investment programmes, including the prioritisation of projects, transferred to Uisce Éireann.

Donegal County Council, and all other local authorities, signed respective Master Cooperation Agreements (MCA) with Uisce Éireann on the 5th May 2023. This MCA replaced the previous Service Level Agreement and facilitates the transfer of responsibility for the direct management of public Water Services in Donegal to Uisce Éireann from an agreed "Effective Date" of the 13th September 2023, up to 2026.

The Council's capital & design division continues to play a key role in the rollout of projects locally on behalf of Uisce Éireann, under the terms of the MCA. There has been an extensive programme of major water and wastewater projects progressed through planning, design, and construction stages in Donegal as part of the current Uisce Éireann Capital Investment Plan since 2014.

Minor capital upgrade/replacement requirements to wastewater treatment infrastructure have been identified at a number of locations throughout Donegal by the Elected Members and Water Services staff in recent years. This was highlighted as requiring investment during the County Donegal Development Plan 2018-2024 process. These needs include essential upgrades required to wastewater treatment plants that impact negatively on bathing water quality, and increase risk as regards the retention of our highly valued Blue Flag beaches. The programme also includes investment required in advance of the rollout of the Uisce Éireann Capital Investment Plan (2020-2024), and essential upgrades of prioritised housing estate wastewater treatment plants.

The Investment Plan is UÉ's capital budgetary plan for the water services network for the period of 2025-2029. This will be the fourth plan to date, with previous ones being from 2014-2016, 2017-2019, and 2020-2024. The plan will prioritize investments in drinking water quality, leakage reduction, water availability, wastewater compliance, efficiencies, and customer service. The plan aligns with the strategic direction given in the Government's WSPS and UÉ's longer-term WSSP. The plan will undergo several phases of stakeholder consultation and CRU review before submission as part of the RC4 regulatory period review process.

The first phase of stakeholder engagement on the methodology for the preparation of the plan was carried out by Uisce Éireann in April and May 2023. The draft investment plan was open for submissions from local authorities up to the 5th of May 2023. Uisce Éireann undertook a second phase of engagement with stakeholders on the Draft Investment Plan in Q2/Q3 2023, before submitting a Final Investment Plan to the CRU later in 2023. Donegal County Council made a submission to Uisce Éireann during both phases of the consultation process. The submissions focused on the importance full engagement with Local Authorities in the development of County Development Plans aligning with both local and national priorities. The lead in relation to development should be taken from local authorities to ensure that investments are targeted to meet local needs.

5.1.2 - Group Water Schemes takeover by Uisce Éireann

The Group Water Scheme takeover process requires that all technical, legal, and financial requirements meet the standards set out by Uisce Éireann.

Under the Multi-Annual Rural Water Programme, funding is available to assist group water schemes in the takeover process.

Donegal County Council's Rural Water Team has been engaging with group water scheme committees and Elected Members in order to progress the takeover of group water schemes where requests have been received.

5.1.3 - Multi-Annual Rural Water Programmes 2019-2021 & 2024-2026

The Rural Water programme has provided a very effective and beneficial means of delivering improvements to water services at a local level over the past decade. The primary focus over the last number of years has been to improve water quality and supply to private group scheme consumers, and to bring the schemes into compliance with the Drinking Water Directive.

Donegal County Council received an allocation of €2,724,826 in October 2019 in relation to projects under the Multi-Annual Rural Water Programme, with a subsequent allocation of €2,894,297 received for Townawilly GWS. Progress has been made on a wide variety of projects during 2024, and a number of these projects will continue into 2025.

A new multi-annual programme for 2024-2026 was announced by the Government in early 2024, for which the Council made a comprehensive application. In November 2024, Donegal received an allocation of $\{6,059,108,$ encompassing 12 individual applications.

The Council is engaging with the Department on a range of other submitted applications, for some of which the Department has requested further information.

The following table sets out the estimated projected allocation for County Donegal under the Rural Water Programme for 2025, 2026 and 2027:

5.2 – Environmental Services

5.2.1 - Landfill Restoration Programme

Donegal County Council was granted waste licences by the EPA for six landfill facilities under the Waste Management Act 1996. All six facilities are now closed. The waste licences granted required the Council to carry out engineered restoration works at all six facilities within a certain timescale following their closure. Five of these facilities had been restored, with work at the Balbane Landfill Facility nearing completion. Details of the Balbane works, and further infrastructural works to reduce operational costs are detailed in sections 5.2.2 - 5.2.4 below.

5.2.2 - Balbane Landfill Facility

A contract to restore this facility by means of the construction of an engineered cap and an Integrated Constructed Wetland commenced in 2021 and was substantially completed in early 2023. The total final cost of the scheme was €2.97m, which has been fully funded by the Department of the Environment, Climate & Communications. A retention payment will be due to the works contractor in Q4 2024 and Q1 2025.

5.2.3 - Ballynacarrick Landfill Site

Leachate from Ballynacarrick landfill is currently transported to Letterkenny Wastewater Treatment works for treatment. It is proposed to develop an Integrated Constructed Wetland (ICW) at Ballynacarrick Landfill site as a lower-cost alternative. The design, tender and construction of an ICW, with associated land acquisition, is currently estimated to cost €4.5m. Department funding is awarded annually for these types of landfill works. It is anticipated that, in addition to the funding received in 2023, further funding is expected to be provided in 2025-2027. It is envisaged that the vast majority of the cost of the project will be Department grant funded.

5.2.4 – Other Landfill Works

Hydro-geological studies have been completed at all six licensed landfills in recent years, as required by the EPA. These studies have given rise to a programme of further investigation and remedial works at all six sites. A cost of $\le 200,000$ over three years is estimated. Minor capital upgrades/replacements are an ongoing feature of landfill maintenance at all sites, with an estimated $\le 100,000$ being required annually.

Local Authorities, the Environment Protection Agency (EPA), and the Waste Enforcement Regional Lead Authorities (WERLA) have also engaged in a process to complete risk assessments in relation to historic landfill sites (Section 22 Sites) across the country. DCC received funding for works at a historic site in Dungloe in recent years from the Department of the Environment, Climate and Communications and it is anticipated that further funding will be allocated in the coming years.

The estimated cost of progressing the above listed works is summarised in the table below. Delivery of the projects will depend on securing funding from the Department of Communications, Climate Action and Environment, and will require some cofinancing from Donegal County Council.

5.3 Recycling Centres

The Council-owned Recycling Centres at Letterkenny, Milford, Stranorlar, Carndonagh, Laghey and Dungloe are managed and operated by a contractor on behalf of the Council.

Extensive capital infrastructure has been advanced at the six centres, each of which has an area where recyclables may be recycled free-of-charge and an area where charges apply. Items such as glass, cans, textiles, batteries, and electrical goods are all accepted free-of-charge.

Annual capital maintenance works is programmed at each of the recycling centres countywide.

5.4 Bring Banks

The Council has progressed capital works at over 75 Bring Banks sites throughout the County where members of the public may recycle glass, cans, and textiles.

Bring Banks plastic receptacles are subject to high levels of wear and tear, and the banks and internal cables are monitored regularly. They need to be maintained to a high standard and are replaced by Donegal County Council where required. The cost of purchasing a new bring bank is \in 550. There are 488 bring banks throughout County Donegal. A programme of replacing 15% of banks annually is needed in order to maintain these facilities and sustain their use by the public. An annual provision of \in 40,000 over the period 2024 – 2026 is required.

An incremental programme of upgrading the Bring Bank facilities in County Donegal continues to be implemented on an annual basis. Depending on the site, upgrading works can include the installation of fencing around the site, construction of a plinth, signage, and the installation of CCTV. A new site in Leitirmacaward has recently been completed and discussions are ongoing with regard to a relocation of the site in Glenties.

The annual cost of this work countywide is estimated to be in the region of €60,000 for 2025-2027.

The above capital programmes for recycling centres and bring banks will require funding from Own Resources. Opportunities to reduce the financial burden on the Council will be pursued if new grants arise.

5.5 - Public Convenience Capital Investment Programme

There is a variety of public-convenience services provided across the County at 55 locations. This ranges from:

- Permanent Council-owned structures (some of which are open on a seasonal basis), which are maintained by a combination of Council staff and community groups.
- Permanent privately-owned facilities operated with Council subvention.
- Temporary beach services during the bathing season
- Year-round temporary services at key Community & Enterprise promoted locations.

A further review of the type of public conveniences that are appropriate for different situations throughout the County has been initiated by the Environment. This review includes consideration of the following headings:

- Development of a capital investment programme to carry out essential improvements at prioritised existing public conveniences.
- Improved accessibility at public conveniences
- Enhancement of public convenience services provided through increased engagement with community groups and the business community via the Community Toilet Scheme
- Working closely with the DCC Regeneration Team to include enhanced accessible public conveniences in their programme countywide.

The estimated cost of the public convenience capital investment programme for the three years 2025 – 2027 is summarised in the following table.

The work programme is to be resourced through a combination of Own Resource and Department funding.

5.7 - Coastal and Beach Improvement

The Donegal mainland coastline is 1,134km long, and constitutes over 17% of the total national coastline. Donegal County Council actively maintains and promotes 21 Designated Bathing Areas (DBAs) under varying National and International initiatives. These DBAs alone require considerable maintenance and investment.

An increasing number of visitors are enjoying our coastline each year. This coastal tourism is promoted by the Wild Atlantic Way campaign, with specific locations being promoted through initiatives such as the international Blue Flag and Green Coast beach awards. There is a need to meet the requirements and expectations of visitors to our coastline to complete their experience.

A review of facilities and services at our 21 designated bathing areas was undertaken by DCC in recent years and was considered by the Climate Action and Environment Strategic Policy Committee. Of the 21 designated beaches, 14 beaches have had infrastructural improvements in recent years to improve accessibility for visitors of all abilities. A further seven beaches now require investment to enhance access. The cost estimate for these works is 140,000 per annum. The work undertaken in this area will be crucial in continuing to complement the Council's 'staycationing' initiatives.

The Coastal Erosion programme includes ongoing monitoring in follow-up to previously completed Coastal Erosion Studies. A further €30,000 per annum is programmed for a number of localised Soft-Engineering Coastal Erosion projects throughout the County.

5.8 – Leisure Centres

The following is an overview of the various projects that are ongoing at the 4 Leisure Centres owned by DCC as well as the Buncrana site.

5.8.1 - Buncrana Leisure Centre

The proposed refurbishment of Buncrana Community Leisure Centre continues to be progressed by Donegal County Council, in collaboration with the Buncrana Community Leisure Centre Committee. The following is the current position with the project;

- Part 8 Planning was approved at the January 2024 Plenary Meeting of the Council
- Stage (i) Preliminary Design is complete at a cost of €68k plus VAT.
- Stage (ii) Detailed Design is at Stage 2b which is 50% complete and currently paused at a cost of €68k + VAT.
- An application to the *Large-Scale Sports Infrastructure Fund (LSSIF)* on 1st July 2024
- Donegal County Council has continued to engage with the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media. They have confirmed that this remains a live application process. Funding was not provided for this project in the first allocation announced on 4th November 2024. Since then, the Department has engaged with Donegal County Council and confirmed that the project is on a reserve list of projects and that "As additional LSSIF funding becomes available projects on the reserve list should then be able to be funded."
- Donegal County Council will also continue to explore other funding opportunities that may be available such as Shared Island and Re-Power Buncrana under the RRDF Programme.
- Should *Stage* (ii) *Detailed Design* be brought to completion in 2025 ie *Tender Action, Evaluation and Contract Award* the Design fees incurred would be €305,000 + VAT.

5.8.2 - Ballyshannon Leisure Centre

Funding of €300,000 (70%) under Sports Capital & €78,734 (30%) under Community Energy Grant was provided for Energy Efficiency measures at Ballyshannon Leisure Centre. The works are practically complete and are at commissioning stage.

These two projects when completed will result in 30% Energy Savings and a reduction of 160 tonnes per annum of Carbon emissions. A further grant of 190,056 was secured recently for a Hydro Pool under the 2023 Sports Capital Programme, these works are currently at Design / Feasibility Stage.

5.8.3 - Waterworld

Part 8 Planning Approval was obtained at the September Plenary meeting of the Council for a refurbishment of the existing Changing Village and a new entrance foyer. These works have subsequently been tendered out and it is expected that a contract will issue for $\in 1.9$ million with works to be completed in time for the 2025 season. An urgent issue has also arisen with the Air Handling Unit in the main pool hall which is at *end of life*, this project alone could cost up to $\in 500,000$. A design team is to be appointed to progress this matter as well as an *Investment Grade Audit* of all energy opportunities.

5.8.4 - Aura Leisure Centre, Letterkenny

Aura received €180,934 (70%) under the 2023 Sports Capital Programme for LED lighting & barriers at the athletic track as well as a new Mezzanine level studio space. An application under the *Support Scheme for Renewable Heat* SSRH is also being prepared for replacement of oil with a new biomass burner at a projected cost of €500,000. This project is estimated to save 582 tCO2e equating to over 20% of the gap to target in DCCs heat emissions under the LA Climate Action Plan.

5.8.5 - Finn Valley Leisure Centre, Stranorlar

Funding of €200,000 (70%) for energy efficiency measures under the 2023 Sports Capital Programme was recently received. An announcement is also due on a Community Energy Grant application for similar works. A detailed assessment of energy usage as part of the project is also ongoing with further measures to be taken as soon as a programme of actions has been agreed.

5.8.6 - Leisure Centre Capital Maintenance Programme

Notwithstanding the Capital expenditure above there is also an emerging need for capital maintenance and replacement works at each of the existing leisure centres in the County which range in age from 13-32 years. This investment is necessary to protect the assets and to maintain each facility to a required standard to attract and retain customers. Failure to do so will have a detrimental effect on longevity of these vitally important Community facilities. Capital replacement requirements will be informed by periodic structural and fabric assessments of the various facilities. This programme is currently estimated to require an annual investment of €250,000. This work programme is to be resourced through a combination of DCC and Department funding.

5.8.7 -Leisure Centre Energy Efficiency Programme

An energy efficiency *invest-to-save* programme is being developed by DCC for improved energy performance systems and CO2e reductions at the existing leisure centres to address climate action targets and the significantly increasing energy & fuel costs. This programme will require an estimated €1.5m over the period 2025-2027. This work programme is to be resourced through a combination of DCC, SEAI and Department funding.

It is intended to take the learnings from the recently completed Ballyshannon project and other best practice initiatives nationwide into projects in our other Leisure Centres.

The following table outlines the proposed budget costs;

5.9 - Flood Relief Schemes

In May 2018, Minister of State at the Department of Public Expenditure and Reform, Kevin Moran, T.D. launched 29 Flood Risk Management Plans for all the main river basins, identifying an initial total of 118 flood relief projects to protect the main flood risk areas throughout the country. This number increased to 119 with the addition of the Burnfoot project, following a Cost Review Report completed in May 2018, which was commissioned in the aftermath the 2017 flood. These Plans and projects are a key part of the overall flood risk management strategy set out in the National Development Plan 2017 − 2028, involving total investment of almost €1 billion over the ten-year timeframe of that plan. As it is not possible to implement all of the 119 projects at the one time, a total of 57 projects have been prioritised, following discussions with local authorities, for the initial tranche of investment and delivery based on the level of risk and number of properties to be protected.

In total, sixteen flood relief projects have been identified for County Donegal as part of the 119 projects. Six of the Donegal projects were identified to be progressed in a first phase of implementation. These projects include Lifford, Castlefin, Burnfoot, Na Dúnaibh (Downings), Glenties, and Kerrykeel. In November 2019, the OPW approved the progression of three further flood relief schemes in Donegal - in Ballybofey and Stranorlar, Buncrana and Ramelton. In addition to these nine, there is an ongoing flood relief project at design stage for Raphoe. The OPW and the Council are working closely to progress these projects, with the OPW leading on the delivery of Lifford and Raphoe, and the Council leading on the remaining eight projects. consultation processes have been completed for the FRS in Ballybofey and Stranorlar, Buncrana, and Ramelton in 2021, in addition to the consultations that took place on the other schemes in 2020. A wide variety of survey, modelling, and optioneering works been onaoina across all schemes. Α dedicated have website, www.countydonegalfrs.ie, has been established and provides a portal to information on all schemes. Quarterly newsletters are published, and quarterly briefing notes are provided for elected members on all schemes.

As a minimum, each scheme must consider climate change through the Climate Change Adaptation Plan required as a deliverable under the brief. In summary, the plan requires that the Consultant assess and consider the potential impacts of climate change in the development and design of the options for a preferred Scheme. This includes the consideration of Potential Future Schemes (flood relief schemes) that may be necessary to provide the required Standard of Protection (SoP) under various future scenarios (which include sea level rises, increased fluvial flows and urbanisation). The plan also includes the identification of the potential amendments or additions to the options for a preferred Scheme under current conditions (referred to as Adaptation Options) that may be necessary over time to maintain the defined SoP, or in other ways mitigate potential future risk, in a cost-efficient and locally acceptable manner.

Green measures, such as Nature-based Catchment Measures, have been very much to the fore in Climate Change Adaptation drafts to date. These include consideration of leaky dams, gravel riffles, hedge plant and many more nature-based interventions which would be implemented over the lifespan of schemes to reduce flows from the catchment and dampen the impacts of climate change. 2024 saw the allocation of approximately €50,000 by OPW to undertake a pilot study of nature-based interventions with the draft roadmap to be issued in December 2024 followed by consultation in early 2025.

The Minister of State for the Office of Public Works announced on the 2nd May 2023 that flood relief schemes for Donegal Town and Letterkenny are to proceed. The announcement also included for the funding for three additional staff for Donegal County Council, the OPW is now funding five staff in total in Donegal County Council who are dedicated to managing, jointly with the OPW, flood risk schemes across twelve communities in Donegal.

The schemes will help the communities in Letterkenny and Donegal who have suffered the impacts of flooding over a long period of time. The OPW is also testing a new delivery model for these schemes, which will inform the best way to implement 60 more schemes across Ireland. The Government has committed €1.3 billion to deliver these schemes by 2030 and protect 23,000 properties from river and coastal flood risk.

Currently there are twelve flood relief schemes at design across Donegal that are due to go to planning as follows:

- Raphoe, being led by the OPW has been submitted to the Minister for Public Expenditure, National Development Plan Delivery and Reform for confirmation under the Arterial Drainage Acts. A decision is expected shortly
- Planning permission is scheduled to be submitted for flood relief schemes being led Donegal County Council over the coming 12 months for Burnfoot, Castlefin, Na Dúnaibh (Downings)
- Glenties has been the subject of Nature-based Solution pilot study with public consultation expected in Q1 2025.
- Buncrana and Luddan, Ramelton, Ballybofey and Stranorlar schemes are continuing through option development phase with emerging preferred options expected in Q1/Q2 2025.
- Letterkenny and Donegal Town are in a data gathering pilot phase.

5.10 - NorthWest Energy Agency

DCC / DCSDC are continuing to develop the North-West Regional Energy Agency (NWREA) to accelerate the region reaching net zero energy emissions by 2045. The funding strategy for the establishment of the NWREA has, to date, focused on the following aspects:

- Establishing the North West Energy Agency in Donegal initially (staffing, office etc.)
- Project funding to deliver the Agency's work programmes as part of the journey towards a region with net zero-energy emissions by 2045.
- Other funding streams are being considered, as outlined below.

The two Local Authorities have jointly been successful in attracting the following funding for advancing the establishment of the NWREA and implementation of the work programmes, including:

Both Local Authorities jointly agreed a strategy of reaching net-zero carbon emissions from their energy systems by 2045, with the NW Regional Energy Agency (Agency) now established and will be the main delivery vehicle. The Agency is a standalone Company and became operational in 2023.

The Agency has recently secured a range of external funding to advance the Agency's Work Programmes, which will target energy efficiency improvements in domestic and public buildings initially. Funding sources include, EU LIFE Programme, EU City Facility and the Shared Island Fund.

Donegal County Council are anticipating a successful outcome from the ELENA funding application (€3.19 million) which was submitted in Q1 2024.

5.11 Burial Grounds

The Council's Roads & Transportation Directorate oversee a limited maintenance programme of a number of historic burial grounds in Donegal. Other burial grounds are largely controlled by various churches who generally provide the necessary burial arrangements. The Council has not provided a new burial ground in an extended period. The Elected Members have raised this matter at Plenary Council for a number of years.

In 2020, Donegal County Council undertook a significant survey of graveyard provision and capacity in the county. The survey examined the status of all graveyards within the functional area of Donegal County Council.

The Council is actively considering the provision of a new burial ground and is working with a number of stakeholders, including;

- The Inter-Church Group on Community Graveyard Provision in Donegal
- The Black and Ethnic Minority Group
- The Intercultural Platform
- Non-Denominational Groups

This engagement has allowed the Council to gain a wider understanding of the requirements for multi-denominational burial arrangements in Donegal.

The initial focus has been on the area of greatest need, namely the greater Letterkenny area, which has the largest population and the greatest cultural diversity. This approach will be considered as a potential model for the rest of the county.

Suitable site assessment criteria has been developed and include;

- Location
- Public consultation
- Accessibility
- Environmental impact
- Topography
- Geology

The Council has identified potential sites in the greater Letterkenny area.

An essential part of the process has been for the Council to actively engage with the stakeholders listed above, with the Elected Members, and with other relevant groups. The Council has engaged with all other local authorities nationally regarding their models in burial ground provision and management.

An update on progress to date will be reported back to the Climate Action and Environment SPC and the Elected Members in Plenary Council when concluded and as soon as it is appropriate to do so.

Therefore, funding for the provision of a Burial Grounds Capital Programme in County Donegal in the 2025 – 2027 Capital Budget is proposed as follows. Costs will include for scoping, preliminary design, public consultation, environmental assessment and planning, land acquisition, and construction.

5.12 Enhanced Defective Concrete Blocks Grant Scheme

The Minister for Housing, Local Government & Heritage announced the commencement of the Enhanced Defective Concrete Block Grant Scheme on the 3rd July 2023 under the Remediation of Dwellings Damaged by the Use of Defective Concrete Blocks Act 2022.

Donegal County Council is tasked with administering the Enhanced Grant Scheme, on behalf of the Department of Housing, Local Government & Heritage. Donegal County Council had issued approval to 849 applications prior to the commencement of the Enhanced Scheme. The Housing Agency determines the remediation option and grant amount for all other applicants.

Funding for the administration of the Enhanced Defective Concrete Blocks Grant Scheme in County Donegal in the 2025 – 2027 Capital Budget is estimated as follows. Costs will include for payment of grants to homeowners for remediation works, emergency works, ancillary costs and engineers' fees, as well as DCC staffing costs.

6.1.3 - Outdoor Recreation Strategy 2023-2029

The Donegal Outdoor Recreation Strategy 2023-2029 (DORS) which was led by Community Development Division is action focused, building on a comprehensive and documented data audit of the existing, proposed, and potential future for outdoor and associated recreational amenity in Donegal.

Donegal's first outdoor recreation strategy is closely aligned with the ambitions of the National Strategy for Outdoor Recreation - Embracing Our Great Outdoors and supports the objectives of Donegal County Donegal Development Plan 2024-2030, the Local Economic and Community Plan 2023-2029 and the emerging Tourism Strategy for Donegal.

The Donegal Outdoor Recreation Strategy will guide and facilitate the sustainable development and management of outdoor recreation up to 2029 and beyond to 2040, informing an authentic outdoor recreation experience for all, while protecting the unique and diverse landscape and waterscapes and delivering social, economic and environmental benefits for local communities and visitors alike.

The DORS sets out six themes including Collaboration, Environmental Integrity, Facilities and Visitor Servicing, Inclusivity, Training and Education & Awareness and Participation and is supported by 59 strategic actions to guide, nurture and sustain outdoor recreation in Donegal. These actions will be aligned to funding programmes such as the Project Ireland 2040 RRDF, EU funding, ORIS, Town & Village Renewal, CLAR and Leader Programmes. The Donegal Outdoor Recreation Strategy provides a clear blueprint to sustainably grow and improve both land and water-based recreation activities throughout the county and identifies a range of initiatives, interventions and strategic actions to be implemented over the lifetime of the Strategy.

As one of only a small number of local authorities across the country who have developed an outdoor recreation strategy, Donegal County Council are now actively delivering on the actions as outlined in the Strategy, across sectors including Coillte and Failte Ireland and most specifically with Sport Ireland and our colleagues in the Donegal Sports Partnership.

Donegal Co. Council will continue to seek Capital funding opportunities over the period 2025 – 2027 to develop and implement the objectives as set out in Outdoor Recreation Strategy 2023-2029 (DORS).

The project is currently under review by Donegal 2040 DAC following an unsuccessful construction tender process. A separate URDF funded demolition works package will be completed in 2024.
Repowering Buncrana	RRDF and Own Resources	This project will develop the harbour and shorefront environment, provide better linkage to the main street and develop the former Garda Barracks in office accommodation. The project has received funding approval of

An Integrated Design Team has been appointed; tender package expected Q4 2024 with construction expected to commence Q1 2025.

6.3.2 - Housing Estate Improvement Works and Unfinished Housing Estates

While the national Unfinished Housing Developments database has not been updated in several years, some progress has been made on the fourteen estates in the County which remain on the list. Developers have reengaged, and works are in progress or new planning applications have been submitted in a number of these and they remain at varying levels of completion and occupation. Other potential routes to resolution will continue to be pursued for these remaining sites.

The Council continues to work through the remaining unfinished estates which received funding under the Government's Site Resolution and Taking in Charge funding programmes. Further resolution works will continue as part of the 2025 UFHD's Work Programme with an expected spend of €200,000. No further funding programmes have been announced in relation to these developments.

6.3.3 - Taking-in-Charge - Residential Housing Estates

The Council continued to progress the taking-in-charge of residential estates throughout 2024 and will continue this process throughout 2025. Up to the end of October 2024, a further 24 estates were sent to Municipal District meetings seeking approval from Members to have them taken in charge in accordance with Section 180 of the Planning Act.

Proactive engagements continue with Uisce Éireann in respect of approximately 120 estates, seeking their agreement to proceed to Taking in Charge, and this work continues in relation to all the legacy estates for which applications have been received. Government decisions around the roles and responsibilities for water services infrastructure in residential estates may impact on the process involved.

Significant progress has been made in respect of the estates which have been awarded funding under the Multi-annual Developer Provided Water Services Infrastructure (DPI) Resolution Programme. These estates are not already connected to the Uisce Éireann controlled or owned network. Works to resolve the DPI at St. Jude's/Hazelwood in Lifford, Doonan Court in Donegal and Ras na Mhuilleann & Flaxmill Court in Carrigans have been completed. Doonan Court and Flaxmill Court have been taken in charge, while further works within the other estates are required before the process can be completed in early 2025. Works have also commenced on the largest project, Dromore Park, Killygordon, and it is anticipated that these will be complete by Q2 2025. Discussions are advancing with Uisce Éireann in relation to Woodlands, Ballyshannon and it is expected that works will be completed in early 2025. The funding allocated will be 75% of the estimated cost of the works with the Council obliged to provide the matched funding requirements. Government decisions on responsibilities may impact these works but it is a condition of drawdown that the entire estate is taken in charge.

Agreement has been reached with Uisce Éireann in relation to several estates with problematic sewage pumping stations, where there are insufficient planning securities or bonds to complete the resolution works required to bring the estates to an acceptable standard. These estates are already connected to the Uisce Éireann controlled or owned network. Works have been completed under this arrangement at Errigal View in Letterkenny and are underway at Ash Meadows in Stranorlar in Q4 2024. Uisce Éireann have funded the element of the works associated with remediation of the water and wastewater services, and the Council are responsible for funding all other elements of the works, including roads, footpaths, and street lighting.

Similarly, positive engagement with Uisce Éireann in respect of Minor Site Resolution plans for numerous other estates continue to allow works to be carried out to improve the levels of service and completion of these estates so that they can also be taken in charge.

Several unresolved sites continue to be addressed using funds realised from developers' bonds. It is anticipated that around €300,000 from this funding source, subvented by the Council's own resources where appropriate, will continue to be spent in each year during 2025-2027.

The Council will continue to engage with relevant parties to try to arrive at acceptable resolutions for those estates which have not yet been completed but where planning bonds or securities are available for resolution works.

6.4: Planning Services Division

6.4.1 - Development Charges / Development-Contribution Scheme

In accordance with Circular Letter Finance 08/2008, the estimate of development contributions (DCS & Specific Charges) to be collected in 2025 (based on receipts to date in 2024) is circa ≤ 1.88 m.

7. Economic Development, Emergency Services & Information Systems

7.1 - Economic Development Division

- 7.1.1 The Economic Development area is comprised of the Economic Development Division and the Local Enterprise Office (LEO)/Small Business Support Division and is part of the wider Economic Development, Emergency Services and Information Systems Directorate.
- 7.1.2 Both the Economic Development Division and the Small Business Supports Division (LEO) will contribute to the delivery of projects under initiatives including the Border Enterprise Development Fund (BEDF), Shared Island initiatives, Failte Ireland schemes, Enterprise Ireland capital funding programmes, as well as the Urban and Rural Regeneration Development Funds (URDF) and the Rural Regeneration Development Funds (RRDF), alongside colleague Council services.
- 7.1.3 The Economic Development Division is continuing to advance projects and proposals that will have implications for Capital expenditure in the following areas:
 - Land and building optimisation for economic development purposes.
 - Opportunity site acquisition for economic development purposes
 - Funding and investment opportunities from Central Government and State Agencies for economic development purposes
- 7.1.4 A number of projects are currently being advanced, particularly from the perspective of post Brexit offerings for relocation or second site location opportunities. This includes maximising the potential of Council owned land and properties. The need for the development of Serviced Land Initiatives for Economic Development Purposes was identified by Grant Thornton in their Responding to Brexit report and the Economic Development Division is currently working with the Councils Capital Delivery Team and other Council services to develop a multiuse park at The Common, Lifford with similar proposals being considered for other locations in the county.

The completion of these enabling works will allow for the following projects to processed on this site;

- Development of an HSE led Community Hospital & Primary Care Facility
- Development of a Council led Social Housing investment
- Sale of a number of Economic development sites leading to job creation in manufacturing
- Facilitation of the Riverine project with the relocation of a local sports club
- 7.1.5 A new Business and Innovation Quarter is currently being developed in Letterkenny town centre with a view to enhancing greater levels of innovation and business development in the region. This will comprise of the 17,500 sq. ft Alpha Innovation Centre, which will house the Alpha Innovation Team, and the 43,000 sq. ft Beta Business Centre providing over 60,000 sq. ft of Grade A office accommodation in a prime town centre location.

- 7.1.6 The Inishowen Innovation Hub was completed in 2023 and occupancy levels are particularly good in 2024, especially the own door office accommodation offering. The Hub is actively delivering a range of initiatives to enhance innovation and business development opportunities in the area and will work proactively with key agencies including the Local Enterprise Office and Enterprise Ireland as well as the Alpha Innovation team to achieve these ambitions.
- 7.1.7 The Division has also completed in 2024 the Donegal Town Diamond regeneration scheme, comprising a Department of Tourism et al. grant of €250,000 with the balance of funding in the region of €500,000 provided by the Council.
- 7.1.8 It is expected that the Bundoran Outdoor Spaces scheme, funded through a Failte Ireland grant, co-financed the Council will be completed in Q1 2025.
- 7.1.9 Economic Development Capital Investment Programme 2024 2026

The Council's Capital Delivery Team, as well as local technical resources, are progressing the delivery of these capital projects on behalf of the Economic Development Division.

7.1.8 As part of the Economic Development Division, the Strategic Funding Unit continues to proactively engage with potential external funding bodies and agencies, with the objective of matching strategic Council objectives with appropriate external funding programmes, both National and EU, to maximise funding and co-financing opportunities to enable further development in the County. New EU Funding Programmes will continue to open in 2025 and the Strategic Funding Unit will continue to engage with various programme bodies, Council Services and partner organisations with a view to ensuring that the Council is well positioned to avail of opportunities as they arise.

7.2 - Information Systems

7.2.1 Donegal County Council's Information Systems infrastructure serves 106 locations countywide and is one of the largest Local Authority networks in Ireland.

The infrastructure comprises: -

- 84 Servers (mostly virtual machines)
- 1,687 Desktop & Notebook Computers
- 352 Printers/Scanners/Plotters
- 29 Print Management Multi-Function Devices (managed solely by Information Systems)
- 84 Other Multi-Function Devices (managed by Reprographics Section with support from Information Systems)
- 380 Tablets
- 700 Mobile Phones
- 200 Other data devices
- 275 IP Telephone handsets

Together with this ICT infrastructure, a wide range of Council business systems and applications are managed on a daily basis.

7.2.2 In addition to operational support on the networks and applications, a comprehensive systems programme is implemented annually. The systems programme is designed to support the Council's Corporate Plan and Services' Annual Delivery Plans. It assists business units in Donegal County Council to work more efficiently and effectively, as well as delivering improved customer service applications.

Capital Investment Programme

- 7.2.3 Ongoing Revenue budgets fund maintenance and support of existing infrastructure and applications on an annual basis, including significant financial outlays that are made to the Local Government Management Agency and Microsoft.
- 7.2.4 An upgraded networking, hardware, telephony, security and systems upgrade Capital project got underway in 2021. During 2021 Information Systems invested heavily in upgrading the Communications and Network infrastructure replacing core routers at HQ and in the Public Services Centres as well as replacing 60 switches at HQ, Public Services Centres and many other key offices such as the Local Enterprise Centre, Stranorlar Training Centre and Letterkenny Fire Station.

During 2022, Information Systems invested in excess of €200k on implementing an IP Telephony system and Contact Centre Support Solution for the organisation with the rollout of that solution completed in early 2023. This system replaced an Analog PBX Telephone System that was originally installed over 28 years ago.

In 2023-24 new Hyper converge infrastructure (HCI) was tendered, installed and configured in Lifford. This system replaces the legacy Dell server hosting infrastructure. It acts as a disaster recovery solution for systems and data, with upgraded backup and restore speeds and functionality. The HCI supports the Corporate Business Continuity Plan.

In the years 2025 – 2027 the Information Systems Department Capital Expenditure falls into the following main categories:

- Communications and Networking Improvements (Local and Wide Area Network Upgrades)
- Replacement Compute & Storage Infrastructure (HCI)
- Business Continuity & Backup Solutions (HCI)
- Enhanced Information and Cyber Security Solutions
- Digital Transformation & Improved Corporate Information Systems and Applications
- Cloud based desktop office automation systems.
- 7.2.5 Over the last number of years cyber-attacks and similar forms of criminal activity have wreaked havoc across the globe for organisations and businesses, including the public sector. With the advent of Artificial Intelligence, these attacks are becoming more prevalent and realistic. The Council, in common with other public authorities, needs to keep abreast of these threats by using the best defence mechanisms available. Additionally, General Data Protection Regulations (GDPR) became law in 2018, with increased obligations for bodies holding personal data, and increased fines for breaches of these enhanced obligations. The need for continual investment in this area to both protect Council systems and data as well as ensuring compliance with GDPR Regulations, and the incoming NIS2 Directive, is now a given across the public sector. Continued capital investment in our core Server and Storage infrastructure, cyber security solutions and services will be a priority for 2025 and beyond.
- 7.2.6 Over the period 2025 2027 the ongoing systems implementation, software and operating systems upgrade programme will also continue. Work will be prioritised on an annual basis and will target systems and applications with significant payback for the Council in terms of operational efficiencies and security. The recently launched Local Government Digital and ICT Strategy 2030 will shape our Digital Transformation journey towards the target of 90% of all applicable public services being available and consumed online by the citizens of the country by 2030. This ambitious objective of the Connecting Government 2030 strategy will require strong financial support and investment in resources by Donegal County Council in the next 5 years.

Information Systems - Priorities for 2025

- 7.2.7 The priority project for 2025 is the rollout and upgrade to Windows 11 as Windows 10 becomes end of life in Q4 2025. Upgrading and patching of Operating systems is a critical defence method in the ongoing battle against cybercrime. This involves addressing software and potential hardware upgrades to ~1300 devices.
- 7.2.8 In 2025, further investment is required in Security, Management and Monitoring Systems in order to further improve cyber security protection. The recruitment of 2 Cyber Security staff in 2025, at Project Leader and Analyst/Developer grades, will strengthen our commitment to reducing our risk to cyber threats.
- 7.2.9 Investment in other multi-faceted cyber security solutions and services will be required as well in 2025 as the need to have 24x7x365 monitoring of our ICT infrastructure and network is becoming a critical tool to have in our armoury in order to effectively manage the cyber security threats and network performance of the modern world.
- 7.2.10 2025 will see the continued upgrade to switching and routing infrastructure across the network. With the soon to be implemented Gigabit Infrastructure Act, switchover to fibre connectivity and copper switch off will continue to feature as fibre availability increases in the County.

7.3 - Fire Appliances, Associated Vehicles and Buildings

7.3.1 As part of the National Directorate for Fire and Emergency Management (NDFEM) 2023 to 2025 Fire Appliance Procurement Programme, Donegal County Council has been awarded approximately almost €1.07m in capital funding for the purchase of 2 no. Scania P320 Class B Fire Appliances, procured via the Office of Government Procurement 'Framework for Class B Fire Appliances to the Irish Public Sector'. The contract for the supply and delivery was awarded to Sidhean Teo from Co. Galway. Both Class B Fire Appliances are currently being built with an expected delivery in Q1/2025.

- 7.3.2 In addition, and due to specific capital funding from the NDFEM in 2024, the following Fire Service appliances projects are also underway:
 - An 8,000lt Volvo FE320 Water Tanker appliance, at a cost of some €0.281m.
 The contract for the supply and delivery was awarded to Sidhean Teo from
 Co. Galway, with an expected delivery timeframe of Q1/2025.
 - Two Volkswagen Trendline AWD panel vans for fire service operations, to replace fire brigade jeeps that are used to carry sign, lighting and guarding equipment, at a cost of approximately €0.155m. The contract for the supply and delivery of both vans has been awarded to VWGI Ltd in Dublin. A further tender competition will be run for the fitting-out of the vans in Q1/2025, with a project completion date in Q3/2025.
- 7.3.4 Donegal County Council has also been awarded €0.5m in capital funding from the NDFEM to build a stand-alone building at Letterkenny Fire Station to provide additional training accommodation and vehicle storage. The purchase of the necessary land should be finalised in Q4/2024, with the project going to design stage in Q1/2025.
- 7.3.5 The Fire Service has also applied to the SEAI Pathfinder Programme for grant assistance to carry out retrofit upgrades to four fire stations so as to reduce their energy usage and CO2 emissions and improve comfort within Fire Stations. The grant assistance can be up to 30% of project costs, with the remainder funded by the Council itself.

Other than the 30% co-financing costs for the retrofit upgrades, and which is expected to amount to approximately €30,000 over each of the years 2025 – 2027, all other aspects of Building and vehicle Capital funding is provided at 100% rate by the NDFEM.

7.4 - Civil Defence

- 7.4.1 The Department of Defence secured additional funding through the Dormant Accounts Fund in early 2024, to continue the upgrading of the existing vehicle fleet around the country. Following the success of the funding application submitted by Civil Defence, in 2024, Donegal Civil Defence was allocated €34,000 towards the purchase of a replacement rib boat.
- 7.4.2 The current garage space at the Civil Defence Headquarters is no longer adequate to house the Civil Defence vehicle and boat fleet, therefore it is intended to submit a business case to the Civil Defence Branch in early 2025, to fund the erection of a covered parking area for the boats and fire appliance at a cost of approximately €15,000.

8. **Roads Management Office (RMO)**

The Road Management Office (RMO) is a local authority shared service under S.149A of the 2001 Local Government Act. It operates under agreements between each local authority, Transport Infrastructure Ireland, the National Transport Authority and Donegal & Cork County Councils. It is mandated in its work by the Department of Transport (DoT) under performance delivery agreements with it.

The vision of the RMO for 2030 as an organisation is:

"Empowering local government with data-driven evidence-based solutions for efficient and sustainable road asset management while promoting consistency and collaboration with national stakeholders"

Our Mission Statement is:

"Through mandated development and implementation of knowledge based systems and procedures we provide Rd. authorities and sectoral stakeholders with cost efficient high quality services that support implementation of government strategy their obligations goals and objectives."

It is anticipated that the level of expenditure over the 3-year period 2025 – 2027 will be in the order of €110.4M. This is broken down as follows:
