ACHOIMRE AR AN TUAIRISC / SUMMARY OF REPORT

Road Traffic Act 2024 Number 10 of 2024 legislation became law on 17th April 2024. Following the enactment of the legislation relevant sections relating to Speed Limits will be commenced.

Current Speed Limit Review relates to 60km/h default speed limit on Rural Local Roads. Variations to the Default Speed Limits will be permitted by way of local authority Bye-laws in accordance with the published Guidelines for Managing Speed Limits as included in the attached Draft Bye-law Amendment.

Draft Bye-law Amendment also includes 30kph Slow Zone speed limits at public roads within housing estates taken in charge by the Council not previously included in the 2017 Bye-laws and three project specific national road locations. Two locations relating to N56 Letterkenny and one location relating to N15 Lifford.

Speed Limit Review to address default speed limits in Urban Areas and on National Secondary Roads as per Act Number 10 of 2024 to follow in 2025.

(June 2024)

Road Traffic (Special Speed Limits) (County of Donegal) (Amendment) Bye-Laws, 2024

Donegal County Council, in exercise of the powers conferred on them by section 9 of the Road Traffic Act, 2004 (No. 44 of 2004), as amended, and with the consent of Transport Infrastructure Ireland, hereby makes the following bye-laws in respect of the public roads (or parts thereof) within its administrative area, as specified in these bye-laws and further specifies for same the speed limits as below and where speed limits were previously provided for same in the Principal Bye-Laws for those public roads (or parts thereof), the speed limits herein are substituted for those applying under the Principal Bye-Laws.

1. In these Bye-Laws: -

"the Principal Bye-Laws" means the Road Traffic (Special Speed Limits) (County of Donegal) Bye-Laws 2017.

- 2. These Bye-Laws and the Principal Bye-Laws shall be construed together as one and may be cited together as "the Road Traffic (Special Speed Limits) (County of Donegal) Bye-Laws, 2017-2024".
- 3. These Bye-Laws will come into operation on such date or dates as are fixed by order of the Chief Executive of Donegal County Council.
- 4. Paragraph six of the Principal Bye-Laws is amended by addition of the words "local roads" after the word "motorways".
- 5. The Second Schedule to the Principal Regulations (roads where a special speed limit of sixty (60) Kilometres per hour applies), is amended as follows –
- i. By the substitution of the following sub-paragraph (k) in paragraph 44 (road in Letterkenny)

"The N56 from a point 36 metres north-east of the Polestar Roundabout junction to the junction with the Dry Arch Roundabout."

- ii. By the addition of sub-paragraph (ff) to paragraph 44 (road in Letterkenny)
 - "The N56 from a point 50 metres east of the Knocknamona Roundabout junction to a point 1059 metres south-east of the said junction."
- iii. By the substitution of the following sub-paragraph (b) of paragraph 45 (road in Lifford)

"The Lifford to Ballybofey Road (N15) from a point 167 metres north-east of the junction with the Coneyburrow Road (L61443) to a point 615 metres south-west of the junction with the Carricknaslate Road (L61444)."

 - (b) The Whinhill Road (L1921) from a point 212 metres north-east of its junction with the Buncrana Road (Regional Road R238) to its junction with the Burnfoot Road (Regional Road R239).






